Fees:

Application Fee: \$25.00 non-refundable

Include two checks, one for the non-refundable \$25 application fee and one for 1/2 the cost of the entire season. Once per month vendors are required to pay for the entire season in advance. The remainder of your fee will be due no later than July 10. If you are not accepted into the market, your check for the stall rental will be returned to you.

Weekly fee: \$20.00 per 10 X 10 space per week for the entire season. (Total Cost \$540.00)

Bi-weekly fee: \$20.00 per 10 X 10 space for each market day of attendance for the entire season (Total Cost \$260.00)

Monthly fee: \$20.00 per 10 X 10 space per each market day of attendance.

Partial Season Fee: \$20.00 per 10 X 10 space per week.

Late Fees: Payment for the balance of the season paid after July 10 will incur a \$10.00 fee for each week payment is late.

Total Fees for additional Stalls are as follows:

Two Tents \$35.00 per market day (Total Season Cost: \$910.00)

Three Tents: \$50.00 per market day (Total Season Cost \$1300.00)

Four Tents \$65.00 per market day (Total Season Cost \$1690.00)
